TUCKER, A SINGLE MAN, AS GRANTOR, DATED AUGUST 15, 1898 AND RECORDED AUGUST 17, 1898 AT PAGE 262 BOOK "F" OF DEEDS, RECORDS OF SKAMANIA COUNTY, WASHINGTON, CONVEYING THE FOLLOWING DESCRIBED REAL PROPERTY TO-WIT:

COMMENCING AT THE SOUTHWEST CORNER OF SEC. 21 AND RUNNING NORTH 40 RODS, THENCE EAST 40 RODS, THENCE SOUTH 40 RODS, THENCE WEST 40 RODS TO THE POINT OF COMMENCEMENT IN TOWNSHIP 3 NORTH OF RANGE 8 EAST OF W. M., CONTAINING 10 ACRES.

THAT ON THE SAID 15TH DAY OF AUGUST 1898 MARGARET L. SMITH WAS MY WIFE; THAT THE SAID MARGARET L.
