This Indenture, Made this 4th day of April 1925, by and between 1. C. Lott and Charlotte Lott, his wife, parties of the first part to Floyd McKelvey and Hugh B. Smith, parties of the second part, Witnesseth;

THAT THE SAID PARTIES OF THE FIRST PART FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO BY THESE PRESENTS GRANT, BARGAIN, SELL, CONVEY AND WARRANT UNTO THE SAID PARTIES OF THE SECOND PART, THEIR HEIRS AND ASSIGNS, THE FOLLOWING DESCRIBED REAL PROPERTY, SITUATE, LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

- (I) N_2 of SW_4 of SW_4 and SE_4 of SW_4 of SW_4 Sec. 36 Tp. 3 N. R. 7 E. W. M., excepting that land described in deed to Wm. Geopel and wife, recorded at page 159 Book P records of Skamania County, Washington, subject to water right of Skamania Light and Power Company.
- (2) COMMENCING AT A POINT 300 FEET WEST OF THE SOUTHWEST CORNER OF LOT 7 SEC. ITP. 2 N. R. 7 E. W. M., THENCE NORTH TO THE TOWNSHIP LINE BETWEEN TOWNSHIPS 2MAND 3 N. R. 7 E. W. M., THENCE EAST TO THE CENTER OF ROCK CREEK THENCE SOUTHERLY ALONG THE CENTER OF ROCK CREEK TO INTERSECTION WITH THE NORTH AND SOUTH CENTER LINE OF SAID SECTION IT P. 2 N. P. & S. RIGHT OF WAY, THENCE WESTERLY ALONG THE NORTH LINE OF SAID S. P. & S. RIGHT OF WAY 23 CHAINS AND 20 LINKS (MORE OR LESS) TO INTERSECTION WITH THE DIVISION LINE BETWEEN THE EASTERLY ALONG THE NORTH LINE OF SAID RIGHT OF WAY 350 FEET TO A POINT 50 FEET EAST OF AN OLD SKID ROAD, SAID POINT BEING NEAR A SIGN POST MARKED "ONE MILE TO STEVENSON," THENCE NORTHWESTERLY AT RIGHT ANGLES TO LAST DESCRIBED COURSE TO THE SOUTHERLY LINE OF SAID HIGHWAY TO THE INTERSECTION THEREOF WITH THE ABOVE MENTIONED DIVISION LINE OF THE SAID BAUGHMAN D. OLINE AS DESCRIBED AT PAGE 54 BOOK Q OF DEEDS RECORDS OF SKAMANIA COUNTY, WASH. AND SUBJECT TO EASEMENTS FOR ROADS AND TO EASEMENT OF THE NORTHWESTERN ELECTRIC COMPANY FOR POWER LINE.
- (3) Commencing at a point on the Township Line 865 feet east of the section corner of sections I and 2 Tp 2 N. R. 7 E. W. M. thence south 100 feet, thence east 103 feet, thence north 100 feet, thence west 103 feet to place of beginning containing 4 of an acre; also the water from the spring thereof known as school house spring.

M., SAID POINT BEING 2064.7 FEET SOUTH OF THE TOWNSHIP LINE; THENCE SOUTH 37° 31' W 302.5 FEET, THENCE SOUTH 4° 6' W 142.6 FEET, THENCE SOUTH 59° 47' EAST 224.2 FEET TO A STATION ON SAID STATE HIGHWAY NO. 8 KNOWN AS 9+98 THENCE NORTH ALONG THE SECTIONSLINE BETWEEN SECTIONS I AND 2, 496 FEET TO THE POINT OF BEGINNING CONTAINING 1.45 ACRES.
