its own logs, such right to include the manipulation of dams for the impounding of water and for driving purposes, the right to store and assemble its logs in such manner as will not interfere with the storage of logs by the "Vendee", provided that all activities of the "Vendor" in this connection shall be at its own responsibility.

- (19) The "Vendee" shall have the right at any time to make advance payments on account of the purchase price or installment payments in excess of those stipulated, it being understood that the stipulated payments are minimum payments.
- (20) In the event that the "Vendee" is unable to use any of the supplies or equipment purchased from the "Vendor" hereunder, it is understood and agreed that the "Vendee" may sell any such surplus of excess supplies and equipment at prices approved by the "Vendor", and upon such terms as the "Vendee" may desire, Provided that the total purchase price from any such sale shall be paid to the "Vendor" in cash at the time of the sale, regardless of the terms of payment by the purchaser from the "Vendee."
