Parcel No. 1--

Beginning at a point 13 chains and 3 links south of the northwest corner of the northeast quarter of section 22, township 3 north, range 10 east of the Willamette Meridian; thence east 11 chains and 51 links; thence north 13 chains and 3 links to the north line of said quarter; thence east along said line to the northeast corner of the northwest quarter of said northeast quarter, thence south to the southeast corner of said northwest quarter of the northeast quarter aforesaid; thence west to the southwest corner of said northwest quarter of the northeast quarter aforesaid; thence north to the point of beginning, situated in the County of Skamania, State of Washington.

Parcel No. 2--
