The East half of the northwest quarter of Section 20 in township 3 North of range 8 east of Willamette Meridian, containing 80 acres more or less.

To Have and To Hold, the above described and granted premises unto the said Silas Perkins his heirs and assigns forever.

And I the grantor above named do covenant to and with the above named grantee his heirs and assigns that I am lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances, and that I will and my heirs, executors and administrators, shall WARRANT and forever DEFEND the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
