ANDY THOMAS et al to T. O. CARNEY

This Agreement made and entered into this 29th day of Sept. 1927 by and between Andy Thomas and Allard Thomas, hereafter known as the parties of the first part and T. O. Carney hereafter known as the party of the second part, witnesseth;

That for and in consideration of the covenants and agreements to be kept and performed by the parties hereto, in accordance with the terms and conditions hereafter set forth the parties of the first part agree to log the timber from the following described real property, to-wit:

SW½ of SW½ section 15; IW½ of NW½ and S⅓ of NW½ section 22; NE½ and E⅓ of NW½ section 21, all being situate in township 3, H. Range 9 E. of W. M. in Skamania County, State of Washington.

The party of the second part agrees to pay the parties of the first part the sum of \$5.50 per thousand (mill skale) for the first million feet of timber to be cut and logged by the first parties, and the sum of \$6.50 per thousand feet (millskale) for all the remaining timber cut and logged from the said property by the first parties, all of said logs to be loaded by first parties at their own cost and expense, on trucks furnished by the second party, the place of loading to be the spar poll.

It is agreed by the parties that the parties of the first part will deliver said logs to the place aforesaid free from limbs, broken ends and rotten butts and it is further agreed that the first parties will deliver to the place aforesaid at least (3) million feet of logs during the first years of the life of this contract and at least a like amount each year until all the merchantable timber has been cut and logged off of the above described real property.

It is agreed and understood by and between the parties that the first parties at their own costs and expense, will keep and maintain the road from the spar poll to the county road, and the road from the county road to the State Highway, in such condition and repair, so that trucks loaded with logs to capacity may travel said roads at any season/the year, and the first parties agree to work and co-operate with the truckers hauling logs so as to relieve said truckers from any unnecessary delay.

It is agreed by and between the parties here to that the sum of \$1.00 per thousand,
