STEVENSON WATER COMPANY to STATE OF WASHINGTON

IN THE MATTER OF STATE ROAD No. 8.

KNOW ALL MEN BY THESE PRESENTS, That the STEVENSON WATER COMPANY, a corporation organized and existing under and by virtue of the laws of the state of Washington in consideration of the sum of \$ 1.00 in hand paid, receipt whereof is hereby acknowledged, and of other valuable and sufficient consideration received by it from the state of Washington, receipt of all of which is hereby acknowledged, does by these presents remise, release and forever quit claim unto the STATE OF WASHINGTON, all right, title and interest in and to any of the lands crossed by State Road No.8 or the North Bank Highway within Skamania county, Washington, together with all and singular tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, upon the understanding, however, that there is excepted from the foregoing conveyance the present physical crossing of the course of said highway by all water mains and lines of the said Stevenson Water Company, and upon the distinct understanding that each and all of said lines, prior to being covered for the construction of State Road No.8 thereover, shall be adequately protected by permanent covering or by pipe of permanent nature to be constructed at the cost of the state of Washington.

TO HAVE AND TO HOLD, all and singular the said premises, together with the appurtenances unto the said State of Washington forever.

IN WITNESS WHEREOF the said STEVENSON WATER COMPANY, a corporation, has caused this instrument to be executed by its duly authorized officers and its seal to be hereto affixed and has caused the same to be delivered with acceptance of delivery conditioned as above provided on this 10th day of November, A. D. 1927.


