SECURITY BANK & TRUST COMPANY to STATE OF WASHINGTON

IN THE MATTER OF STATE ROAD NO.8

KNOW ALL MEN BY THESE PRESENTS, that the SECURITY BANK AND TRUST COMPANY, successor to the SECURITY LOAN AND TRUST COMPANY, of Red Wing Minn. purchaser at Marshall's sale of all the right, title and interest of the Greenleaf Logging Company, successor of Hamilton Creek Railroad Company, to the rails, frogs, switch points and railroad installation forming a part of the Hamilton Creek Railroad, does hereby grant to the State of Washington the right to encroach upon said logging track material where same shall conflict with the construction of State Road No. 8 in Sections 30 and 19, Township 2 North, Range 7 East W. M. and Section 25, Twp. 2 North Range 6^E. W. M., Skamania County, Washington, as shown in red on attached blue print.

In consideration, therefor the State of Washington shall construct the necessary grade to give the railroad a ten foot roadbed outside the shoulder line of the new highway and shall permit the occupancy of this portion of the right of way of State Road No.8, by grantor's logging truck material, as above described, until December 31, 1935, when all grantor's rights shall accrue to the State.

The occupancy of grantor's property and proposed shift of same to accomodate the highway construction is shown on attached blue print.
