That the object of said action is to foreclose a mortgage executed by Charles O. Williams and Amanda E. Williams, husband and wife, to plaintiff, for the sum of \$2000.00, dated February 26th, 1918, which mortgage is recorded in the office of the County Auditor of Skamania County, Washington, in Book Q of Mortgages, page 55, and covers the following described property, to-wit:
