Tract VII. The southwest quarter (SW $\frac{1}{4}$) of Section ten (10), in township four (4) north, range seven (7) east of the Willamette Meridian;

Tract VIII. The southeast quarter of the northeast quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$) the north half of the southeast quarter (N $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section twenty-one (21) and the northwest quarter of the southwest quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section twenty-two (22) in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract IX. The northwest quarter (NW $\frac{1}{4}$) of Section ten (10), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract X. The southwest quarter (SW $\frac{1}{4}$) of Section twenty-one (21), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract XI. Beginning at a point three hundred (300) feet east and thirty (30) feet south of the northwest corner of the northeast quarter of the northeast quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section twenty-nine (29) in township three (3) north, range eight (8) east of the Willamette Meridian; thence south one hundred (100) feet; thence east fifty (50) feet; thence north one hundred (100) feet; thence West fifty (50) feet; to the place of beginning, containing one lot fifty by one hundred (50 x 100) feet;

Tract XII. The south half of the southeast quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$) of section twenty-one (21), and the south half of the southwest quarter (S $\frac{1}{2}$ of SW $\frac{1}{4}$) of Section twenty-two (22), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract XIII. The southwest quarter of the northeast quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$) the southeast quarter of the northwest quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$) the northeast quarter of the southwest quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) and the northwest quarter of the southeast quarter (NW $\frac{1}{4}$ of SE $\frac{1}{4}$) of section twenty-three (23), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract XIV. The south half of the southwest quarter (S $\frac{1}{2}$ of SW $\frac{1}{4}$) of section twenty-three (23), and the north half of the northwest quarter (N $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section twenty-six (26), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres.

TRACT XV. The northeast quarter of the southeast quarter (NE $\frac{1}{4}$ of SE $\frac{1}{4}$) the south half of the northeast quarter (S $\frac{1}{2}$ of the NE $\frac{1}{4}$), and the northwest quarter of the northeast quarter (NW $\frac{1}{4}$ of NE $\frac{1}{4}$) of section nine (9), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract XVI. The east half of the southeast quarter (E $\frac{1}{2}$ of SE $\frac{1}{4}$) of section ten (10), and the east half of the northeast quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$) of Section fifteen (15), in township four (4) north, range seven (7) east of the Willamette Meridian, containing one hundred sixty (160) acres;

Tract XVII. The east half of the southwest quarter (E $\frac{1}{2}$ of SW $\frac{1}{4}$) and the south half of the northwest quarter (S $\frac{1}{2}$ of NW $\frac{1}{4}$) of section twenty-six (26) in township four (4) north, range seven (7) east of the Willamette Meridian, excepting therefrom the following described property, to-wit: Beginning at a point on the section line between sections twenty-six (26) and twenty-seven (27), in township four (4) north, range seven (7) east of the Willamette Meridian, Skamania County, Washington, which point is marked by an iron pipe set in a mound of stone 1944 feet, more or less, south of the section corner common to sections twenty-two (22), twenty-three (23), twenty-six (26) and twenty-seven (27) said township and range, and running thence easterly and parallel to the north boundary of said section twenty-six (26) a distance of 2640 feet, more or less, to a point on the north and south center line of said section twenty-six (26) marked by an iron pipe in a mound of stone; thence southerly and along the north and south center line of said section twenty-six (26) a distance of 2020 feet, more or less, to the middle of the channel of Trout Creek; thence westerly up and along the middle of the channel of Trout Creek; thence northerly to the west boundary of said section twenty-six (26); thence northerly along said west boundary of section twenty-six (26) a distance of 648 feet, more or less, to the point of beginning, said described tract containing eighty (80) acres, more or less, but with the right in the Wind River Lumber Company, its successors and assigns, to use the waters and channel of Trout Creek for the purpose of flooding, splashing and or driving logs, and to go upon said land for the purpose of flooding splashing and or driving logs in said Trout Creek or in Wind River under the terms of the franchise duly granted by the state of Washington.
