The south half of the northwest quarter ($S_{\frac{1}{2}}$ of the NW $\frac{1}{2}$) the southwest quarter of the northeast quarter ($SW_{\frac{1}{2}}$ of NE $\frac{1}{4}$) and the northeast quarter of the southwest quarter (NE $\frac{1}{4}$ of $SW_{\frac{1}{4}}$) of section eight (8), in township three (3) north of range eight (8) east of the Willamette Meridian;

Tract XXXVI. The east half of the northeast quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$) and the north half of the southeast quarter (N $\frac{1}{2}$ of the SE $\frac{1}{4}$) of section eight (8) in township three (3) north, range eight (8) east of the Willamette Meridian;

Tract XXXVII. All that portion of the northeast quarter (NE $\frac{1}{4}$) of section seventeen (17) in township three (3) north, range eight (8) east of the Willamette Meridian, lying north of Wind River;

Tract XXXVIII. Also: Beginning at the northeast (NE) corner of the northeast quarter of the southeast quarter of the northeast quarter (NE $\frac{1}{2}$ of SE $\frac{1}{4}$ of NE $\frac{1}{2}$) of section one (1), township three (3) north, range seven and one half ($7\frac{1}{2}$) east of the Willamette Meridian; thence east to the east line of lot four (4) of section six (6), in township three (3) north, range eight (8) east of the Willamette Meridian; thence south; thence west; thence north on the west line of lots five (5) and four (4) to the point of beginning, all of said lines being of sufficient length to form a rectangular field, containing twenty-five (25) acres;

Tract XXXIX. The southwest quarter of the southeast quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$) and the southeast quarter of the southwest quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of section twenty-three (23) in township three (3) north, range seven (7) east of the Willamette Meridian.

Tract XL.
