Beginning at a point marked by an iron pin on the west shore of Eagle Lake, which point is the witness corner for the quarter section corner between sections sixteen (16) and twenty-one (21) township two (2) north, range seven (7) east. W. M., thence following the shore line of Eagle Lake north 9 degrees 58' west 109.8 feet; thence north 55 degrees 21' east 140 feet; thence north 9 degrees 54' east 104.7 feet; thence north 61 degrees 47' east 41.45 feet; thence north 3 degrees 04' east 94.8 feet; thence north 15 degrees 28' east 150 feet to a point in the center of the bed of the creek which flows from Tule Lake into Eagle Lake; thence west 577.12 feet; thence south 549.69 feet; thence west 720.24 feet to a point in the center of the county road; thence following the center line of the county road south 2 degrees east 346.8 feet; thence still following the center line of the county road south 45 degrees east 99 feet; thence east 839ffeet to a point which is 40 feet east of the east line of the B.
