WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That I, Alma M. Griffith, of Portland, Multnomah County, Oregon in consideration of One Thousand Dollars, to me paid by Gaylord C. Griffith, of Portland, Multnomah County, Oregon do hereby grant, bargain, sell and convey unto said Gaylord C. Griffith, his heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

Beginning at a point 661.75 ft south of the north east corner of the north west quarter of Section 19, Twp. 3 north Range 10 East Willamette Meridian running thence south along the East line of said quarter section 661.75 ft to an iron pipe, thence westerly 645 feet to an iron pipe; thence north 500 ft. thence westerly 50 ft. to an iron pipe, thence north 162 ft. more or less to a point, thence Easterly 695 ft. to the place of beginning, said tract containing ten acres, more or less.

To Have and to Hold, the above described and granted premises unto the said Gaylord C. Griffith, his heirs and assigns forever.
