## WARRANTY DEED

Lynch, a widower, his heirs and assigns forever, the following described parcel of real estate, situate, lying and being in the County of Skamania and State of Washington to-wit:

All of the Southeast quarter (SE1) of Section Twenty-six (26), in Township two (2) N. Range five (5) E. of the Willamette Meridian, containing one hundred and sixty (160) acres more or less, according to the government survey thereof, subject to a Rail road right of way across said property, said real property located in Skamania County, Washington.

The property above described was granted to the granter herein by A. A. McCormick and wife on September 7th, 1927, by deed recorded in Book V of Deeds on page 400, in which deed the granter herein was erroneously referred to as Hansen Construction Company.
