FIRST:Nellie E.Ash-Right of way dated June 11,1923, acquired by final decree of condemnation No.1452, in the Superior Court of the State of Washington, in and for the County of Skamanaia, Recorded in Book"S " of Deeds at page 891 Records of Skamania County, by which a right of way is granted over the property of Nellie E.Ash, situate in section Eleven (11), Towhship Two (2)North, Range Seven(7) East, W.M. as more perticularly described in said final decree of Condemnation No.1452.

SECOND. Interlaken Resort Company-Right of waydated July 5,1922, granting the right to erect and maintain poles with the necessary wires and fixtures thereon across that certain property belonging to Interlaken Resort Company, situate in the southwest Quarter (SW1) of the South East Quarter (SE1) of Section Eleven(11), Township Two (2) North, range seven(7) East, W.M., recorded in book 5 of deeds on page 629, records of Skamania Coutny.
