WITNESSETH, that the said party of the first part for and in consideration of the sum of ten dollars and other valuable considerations, the receipt whereof is hereby confessed, does by these presents grant, bargain, sell and convey unto the said party of the second part the following described real property in Skamania County, Washington, to-wit;

Lots twenty-one (21), twenty-two (22) and twenty-three (23) of Block Six (6) of the Town of Stevenson according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington.

To Have and to Hold the same unto the said party of the second part, his heirs and assigns forever.

And the said party of the first part does hereby covenant and agree to and with the said party of the second part, his heirs and assigns, that it is the owner in fee simple of said premises; that it has good right to sell and convey the same; that they are free from all incumbrances, and that it will forever warrant and defend the title thereto against all lawful claims whatsoever.
