That part of the Robbins Donation Land Claim No. 38, Certificate No. 288, being parts of Sections 26, 27, 34 and 35 in Township 3 North of Range 8 E W M more particularly described as follows:  
Beginning at a point on the east line of said Robbins D L C forty chains south and four chains and seventy links east of the Northeast corner of said Section 27, and running thence south forty chains to the section line between Sections 26 and 35; thence west twenty chains; thence north forty chains and thence east twenty chains to the point of beginning, said tract containing eighty acres, more or less, according to the public land survey thereof; subject however, to all existing rights of way for the county roads of Skamania County and subject to all taxes or assessments levied since the 5th day of April 1922.
