THIS INDENTURE, Made this 23rd day of June, 1928 between A.C. Sly  
 as Treasurer of Skamania County, State of Washington, party of the first part, and Emil  
 Cretegnny party of the second part; WITNESSETH THAT WHEREAS, at a public sale of real estate  
 held on the 23rd day of June, A.D. 1928, pursuant to an order of the board of County commis-  
 sioners of the county of Skamania, state of Washington, duly made and entered, and after having  
 first given due notice of the time and place and terms of said sale; and

WHEREAS, in pursuance of said order of the said board of county Commissioners, and  
 of the laws of the State of Washington, and for and in consideration of the sum of Eighty  
 Dollars lawful money of the United States of America, to me in hand paid, the receipt whereof
