GEORGE KEELING TO ADA VERNA KEELING

THIS INDENTURE, MADE THIS ELEVENTH DAY OF OCTOBER IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE BETWEEN GEORGE KEELING OF THE COUNTY OF HUMBOLT, STATE OF CALIFORNIA, THE PARTY OF THE FIRST PART, AND ADA VERNA KEELING, HIS WIFE OF THE SAME PLACE, THE PARTY OF THE SECOND PART,

WITNESSETH: THAT THE SAID PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR, OF THE UNITED STATES OF AMERICA TO ME IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DOES BY THESE PRESENTS, GRANT, BARGAIN, SELL, CONVEY AND CONFIRM UNTO THE SAID PARTY OF THE SECOND PART, AND TO HER HEIRS AND ASSIGNS FOREVER, ALL THE CERTAIN PARCEL OF LAND SITUATE, LYING AND BEING IN SKAMANIA COUNTY, STATE OF WASHINGTON, AND BOUNDED AND PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 15, AND THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 14 IN TOWNSHIP 3, NORTH OF RANGE 9 EAST OF WILLAMETTE MERIDIAN IN WASHINGTON, CONTAINING ONE HUNDRED AND TWENTY ACRES ACCORDING TO THE OFFICIAL PLAT OF THE SURVEY OF THE SAID LAND RETURNED TO THE GENERAL LAND OFFICE BY THE SURVEYOR GENERAL OF THE UNITED STATES LESS 1.95 ACRES DEEDED TO SKAMANIA COUNTY FOR ROAD PURPOSES AS SHOWN ON THE RECORDS OF SAID COUNTY AT STEVENSON, WASHINGTON. TOGETHER WITH ALL AND SINGULAR THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THEREUNTO BELONGING, OR IN ANYWISE APPERTAINING, AND THE PREVISION AND REVERSIONS, REMAINDER AND REMAINDERS, RENTS, ISSUES AND PROFITS THEREOF.

TO HAVE AND TO HOLD, ALL AND SINGULAR THE SAID PREMISES, TOGETHER WITH THE APPURTENANCES, UNTO THE SAID PARTY OF THE SECOND PART, AND TO HER HEIRS AND ASSIGNS FOREVER.
