KNOW ALL MEN BY THESE PRESENTS, That E.B.McNaughten and Gertrude H.McNaughten hisband and wife of Portland County of Multnomah State of Oregon in consideration of Ten and more Dollars to them paid by Paul Schindler of County of Skamania State of Washington have bargained and sold, and by these presents do grant bargain, sell and convey unto said Paul Schindler his heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington: West half of the Southwest quarter of section fourteen (14) Township four (4) North, range seven (7) E.W.M. excepting and reserving therefrom the right to use the whole or any part of said land for the impounding of the waters of Wind River and using the same for holding, splashing, driving and booming of logs and timber products; also excepting and reserving rights-of-way for present County and Government roads.

Subject to all rights of way and easements for existing roads of any nature and subject to all existing taxes, liens or easements of whatsoever nature levied, assessed or becoming due against said property subsequent to the 1st day of July, 1923.
