# 14976-AGREEMENT

CHARLES & K COCHRAN: TO MARY O.C.OCHRAN

THIS AGREEMENT, made and entered into this 6th day of July, 1921 by and betwee - n Charles K..C.ochran of Camas, Clark Cpunty Washington, party of the first part and Mary O Kochran of the same place, his wife, party of the second part Witnesseth:

That Whereas the said Charles K.C. ochran and the said Mary O.C. ochran as husband and wife are the owners of certain community property in the State of Washington, and we whereas all the property now owned by them or either of them and located in the State of Washington is hereby declared to be their community property, and whereas the said parties are desirous of providing for the disposition of the said property upon the death of either, under, by virtue of AND in conformity with the provisions of Section 5919 Remington and Ballingers Codes of the State of Washington, and to provide thereby that all the community property of which they may obe then possessed shall pass witout delay or expense, upon the death of one of them, to the survivor.
