KNOW ALL MEN BY THESE PRESENTS That THE SKAMANIA COOPERATIVE TELEPHONE ASSOCIATION, a corporation organized and existing under the laws of the State of Washington, with its principal place of business at Stevenson, Skamania County, Washington, in consideration of Ten Dollars (\$10) and other valuable consideration, does hereby grant, bargain, sell, demise,

release, alien, convey, assign, transfer and set over unto EARL W. GATES all of the following described properties, to-wit:

All telephone and electric lines, exchanges, plants, poles, cross-arms, insulators, wires, aerial cables, underground conduits, underground cables, submarine cables, switch boards, conductors, transformers, electric appliances and apparatus, tools, implements, materials and supplies, and all office furniture, fixtures and equipment, and all of the property of every kind wherever situated, which the said The Skamania Cooperative Telephone Association owns or holds, whether the same be specifically enumerated herein or not, and being in general the telephone properties owned by said The Skamania Cooperative Telephone Association, located principally within the Town of Stevenson, Washington, and within the County of Skamania, Washington, and including among other things the following:

- 1. That certain franchise to use the streets and thoroughfares of the Town of Stevenson, Washington, granted to The Skamania Cooperative Telephone Association and to its successors and assigns for fifty (50) years, by Ordinance No. 28, passed by the Council of the Town of Stevenson, Washington, on November 10, 1908, for a term of fifty (50) years.
- 2. That certain framchise to use the roads and highways within Skamania County, Washington, granted to The Skamania Cooperative Telephone Association, its successors and assigns, by the Board of County Commissioners of Skamania County, Washington, on July 7, 1928, for a term of fifty (50) years.
- 3. That certain franchise No. 347 granted on the 26th day of June, 1928, by the State Highway Committee of the State of Washington, for the use of state Highways within said Skamania County, for a term of fifty (50) years.
