IT IS THEREFORE NOW HERE ORDERED that said will now propounded for probate be and the same is hereby admitted to probate and proved as and is now here decreed to be the true and genuine last will and testament of said Eddie L. Harmon, deceased.

It further appearing to the court that Elizabeth H. Harmon is named in said will as executrix thereof without bonds;

IT IS FURTHER ORDERED that she be and hereby is appointed executrix of the last will of Eddie L. Harmon, deceased, and that letters testamentary issue to her herein upon her filing the oath required by law. Done in open court this 11th day of April, 1922.
