PETITION TO ADMIT WILL TO PROBATE.

To the Honorable George Tazwell, Judge of the above mentioned Court:

Comes now Richard W. Montague, your petitioner, and respectfully alleges that Elizabeth H. Harmon died on the 26th day of September, 1927, at Portland, Oregon, aged about seventy years. At the time of her death and for many years before she had been an inhabitant and resident of the City of Portland, County of Multnomah and State of Oregon, and left an estate therein of a value which your petitioner cannot now estimate.

That said Elizabeth H. Harmon left a will bearing date the 27th day of January, 1926, in the possession of your petitioner, which your petitioner believes and alleges to be the last will and testament of said decendent and which is herewith propounded for probate; that your petitioner Richard W. Montague is named in said will as executor thereof, and said will directs that he be not required to give bond as such.

B. King, (son of Bertley C. King,) of Oregon City, Oregon; and Dwight M. Brosseau a nephew of the decendent, resident in Bellingham, Washington, are the sole legatees and devisees mentioned in said will.

That the witnesses to said will are your petitioner, Gertrude Gray (now Gertrude Gray Stam), and M. M. Matthiessen; that at the time the will was executed the testator was of the age of about sixty-nine years, of sound and disposing mind, not under restraint, undue influence or fraudulent misrepresentation, and in every respect competent by last will to dispose of all her estate, and that the will was executed in all respects according to law and is entitled to be admitted to probate as the true and genuine last will and testament of the decedent.

WHEREFORE, your petitioner prays that said will, herewith propounded, may be admitted to probate and proved as the true and genuine last will and testament of decedent, and
that letters testamentary be issued to your petitioner upon his taking the oath required by
law, and that all other necessary and proper orders be made in the premises.
