LAST WILL AND TESTAMENT

OF

ELIZABETH H. HARMON

I, ELIZABETH H. HARMON, hereby make, publish and declare this my last will and testament, hereby revoking all wills or testamentary dispositions heretofore made by me.

After payment of my just debts and of all proper charges against my estate, I give, devise and bequeath all the property of which I die possessed, or in which I have any right or interest at the time of my death, to the

PORTLAND TRUST AND SAVINGS BANK,

IN TRUST for the uses and purposes and upon the trusts hereinafter expressed, that is to say;

FIRST: To set aside a sum sufficient to pay to my sister, EDITH M. BROSSEAU, the sum of \$200.00 per month during the term of her natural life out of the income thereof.

SECOND: To pay to my sister, JENNIE A. BROSSEAU, the sum of \$1,000.00, and to my brother, GEORGE A. BROSSEAU, the sum of \$1,000.000

THIRD: To pay to REED INSTITUTE, for the use of Reed College, in memory of my beloved husband, E. L. Harmon, the sum of \$20,000.00. I desire that said sum be used as permanent endowment, kept as a distinct fund, and designated the "E. L. Harmon Memorial Fund".

FOURTH: To pay toethe ART ASSOCIATION OF PORTLAND, OREGON, a sum which, in the judgment of the trustee, will be sufficient to produce \$200.00 per year in perpetuity, in memory of my beloved daughter, Helen G. Harmon, the same to be applied, as far as practicable, for distinctively art purposes and designated as the "Helen G. Harmon Fund".

FIFTH: To the UNIVERSITY OF OREGON, for general educational purposes, the sum of \$20,000.00.

SIXTH: To the LIBRARY ASSOCIATION OF PORTLAND, for general educational purposes such as adult education, and especially, in the discretion of the trustee, for use in carrying on free lecture courses, preferably apart from the general maintenance and operating expenses of the library, the sum of \$20,000.000

SEVENTH: To the VISITING NURSE ASSOCIATION, the sum of \$10,000.00.

EIGHTH: To the FRUIT AND FLOWER MISSION, the sum of \$5,000.00.

NINTH: To J. B. King, son of Bertley C. King, for his education at a college or technical school, at such time as his parents shall deem it wise to send him to such college, the sum of \$2,000.00.

My personal effects and household goods I leave to my sisters, to be divided equitably between them by agreement, or, if they cannot agree, by my executor. Articles of a permanent character such as silver and durable furniture, to go upon the death of my sisters, to my nephew DWICHT M. BROSSEAU.

I direct that if, after a sum sufficient to pay the first three legacies herein given shall have been set apart, and after all proper charges against my estate have been paid, the net residue of my estate shall be less or more than sufficient to pay the remaining legacies, such legacies may be abated or increased ratably so as to consume the entire amount of the net residue, and that after the death of my sister, Edith M. Brosseau, the amount set apart to pay the legacy to her shall be distributed in like manner.
