THIS INDENTURE, Made this 19th day of September, 1928, between A. D. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and R. E. Jackson, 865 Haight Ave. Portland, Ore. party of the second part;

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 23rd day of June A. D. 1928, pursuant to an order of the Board of County Commissioners of the County of Skamania State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,
