#15487 WARRANTY DEED

MANHATTAN COMPANY to UNITED STATES OF AMERICA.

THIS DEED, made this 25th day of January 1929, by and between Manhattan Company party of the first part, and the UNITED STATES OF AMERICA, party of the second part, WITNESSETH: That whereas the said party of the first part has filed its application for exchange of certain lands with the United States, under the terms of the act of Congress of March 20,1922, entitled, "An act to Consolidate National Forest Lands," _Vol. 42, United States Statutes at Large, page 465; and

WHEREAS, an application has been submitted by the party of the first part to the Secretary of the Interior to exchange the tracts hereinafter described for for timber on the Snoqualmie National Forest, in accordance with the said act of Congress:

NOW, THEREFORE, in consideration of the premises and in the consideration of the sum of ONE DOLLAR (\$1.00) to it in hand paid, the receipt of which is hereby acknowledged, and for the purpose of affecting such exchange, the said party of the first part does hereby grant, bargain, sell and convey unto the said party of the second part, all the following tracts or parcels of land lying and being in the County of Skamania, State of Washington, to-wit: $NW_4^1NW_4^1$; $SW_4^1NE_4^1$; $E_2^1NW_4^1$, Sec. 27, T. 4N., R. 7 E., W.M. Containing 160 acres.

The said party of the first part does hereby reserve the merchantable timber now standing upon the $N_{2}^{1}NW_{4}^{1}NW_{4}^{1}$, Section 27 for a period of five years from the date of acceptance of title, together with the right to enter upon this land for the purpose of logging and removing same in accordance with stipulations dated October 27, 1928, and filed with the District Forester at Portland, Oregon.
