THE GRANTOR, MARTHA BAUERLE STOCKS, TRUSTEE, for and in consideration of Seven Hundred and Eighty Two Dollars, paid by Skamania County, Washington, do hereby bargain, sell and convey to Skamania County, Washington, a right of way for Permanent Highway Number 14, forty feet wide, being twenty feet on each side of the following described center line:

Beginning at a point on the South line of the North West Quarter of Section Fifteen(15) in Township Three(3) North of Range Ten(10) East of Willamette Meridian, and One Hundred and Seventy Four (174) feet east of the Quarter corner on the West line of said Section Fifteen running thence Four Thousand (4000) feet northerly along the center of said Permanent Highway Number 14 as now laid out and constructed across said North West Quarter of said Section Fifteen (15) to a point in the north line of said Section Fifteen, Four Hundred and Twenty (420) feet east of the common corner to Sections Nine (9), Ten (10), Fifteen (15), and Sixteen (16), of said Township and Range.
