That I was one of the grantees in a certain deed given by John W. Johnson and Rose E. Johnson, husband and wife, as grantors, to A.L. Emmons and E.I. Emmons, dated May 12th 1914, as found of record in book "P" of deed records of Skamania County, state of Washington on page 2 thereof :-
