Jordan a married woman the following described Real Estate, situated in the County of Skamania State of Washington: Commencing at the northeast corner of lot three (3) of Stevenson Park addition in sec. 36 T. 3 N. Range 7 E W.M. according to the official plat thereof on file with the County Auditor of Skamania County, Wash. in Plat Book A records of said County and State, thence west 300 feet, more or less, to the northeast corner of land heretofore sold by the grantors to J.D. Jordan, seceded Mar, 19, 1927 Rec'd Book V.P. 274, then south 150 feet along said J.D. Jordan's east line to the south line of aforesaid lot Three; thence east along the south line of said lot three to the southeast corner thereof; thence in a northwesterly direction along the east line thereof to the place of beginning except land heretofore granted to the public for a road along ore near the east boundary of said lot and excepting right of way hitherto granted for water pipes and service to the Stevenson Water Co or P.S.C.
