WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 23rd day of June A.D. 1928, pursuant to an order of the Board of County Commissioners of Skamania State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,
