COUNTY TREASURER'S DEED

THIS INDENTURE, Made this 22nd day of April, 1929 between A. C. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and Leon P. Montchalin party of the second part;

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 23rd day of June A.
