WARRANTY DEED

J. C. Price et us to Coy Catlin Post 137 of
American Legion

THIS INDENTURE, Made this 29th day of April A.D. 1929 between J. C. Price and Hazel O. Price--Husband and wife parties of the first part, and Coy-Catlin Post #137 of the American Legion parties of the second part,

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of One hundred Dollars, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey, unto the said party of the second part, its heirs and assigns forever, all the tract or parcel of land, lying and being in the County of Skamania and State of Washington, and described as follows, to-wit: 7 1/2 Acres

Beginning at a-point forty two and four fifths rods South and thirty feet West of the Northeast corner of the N.W. $\frac{1}{4}$, of the N. E. $\frac{1}{4}$ of Section 29, Twp. 3, North of Range 8 E.W.M.
