\$300.00 Promissory Note Underwood, Wash. August, 1, 1942.

On August 1st, 1944, two years after date hereof, for value received, I, We, or either of us, Jointly and severally, promise to pay to the order of Henry Bolle, Ella Hooker and Henry Richard Bolle at Stevenson, Washington the sum of Three Hundred Dollars in United States Gold Coin of the present standard of weight fineness and value, with interest from maturity at the rate of six per cent per annum until paid, payable after maturity only in like Gold Coin, and if not paid as it become due, to be added to the principal and become a part thereof and to bear interest at the same rate.
