FREDRICK LUTHY, DECEASED.) ORDER ADMITTING WILL TO PROBATE.

Now at this time comes Fred O. Luthy, and petitions the Court to admit to Probate a certain document purporting to be the Last Will and Testament of the above named Fredrick Luthy, deceased, and that he be appointed executor and that Letters Testamentary be issued to him, and that Truman Butler, E. O. Blanchar and J. M. Culbertson, be appointed appraisers of said estate; and it appearing to the Court that said decedent died on or about the 24th day of February, 1919, in the County of Hood River and State of Oregon, and that at the time of his death he was a resident of said county; that he left an estate in said County of Hood River, Oregon, consisting of real and personal property of the probable value of \$9500; that the next of kin and heirs at law of said deceased are as follows:

Fred O. Luthy, age thirty-one, a son, residing at Portland, Oregon; Edwin J. Luthy a son, age 23, residing at present in Tours, France; Elma Luthy, a daughter, age thirty-four, residing at Castle Rock, Washington, and Rosa Luthy, a daughter, aged 26, residing at Portland, Oregon.

And it further appearing from the testimony of J. M. Culbertson, that the said decedent on the 22nd day of July, 1918, in his presence and in the presence of F. H. Coolidge, the other subscribing witness, who is now without the State, executed the will now propounded for probate; and it appearing to the Court that said instrument is the last will and testament of said decedent, and that it was executed in all particulars according to law; that the said decedent at the time he executed the said instrument as aforesaid was upwards of sixty-two years of age, and he was at that time of sound and disposing mind and not laboring under any restraint or undue influence, and that in said Last Will said petitioner Fred O. Luthy, was named as executor thereof.

It further appearing that Truman Butler, E. O. Blanchar, and J. M. Culbertson are residents and freeholders in said County of Hood River, Oregon, and in every way qualified to act as appraisers of said estate;

IT IS ORDERED that said document heretofore filed purporting to be the last will and testament of the said Fredrick Luthy, deceased, be admitted to probate as the last will and testament of the said decedent; that Fred O. Luthy, the petitioner herein, be and he is hereby appointed executor of said will, and that Letters Testamentary issue to him upon his filing in this Court a good and sufficient bond in a sum not less than \$13,500 to be approved by this Court; and that Truman Butler, E. O. Blanchar and J. M. Culbertson be and they are hereby appointed appraisers of said Estate.
