Addie M. Ferguson having on the 1st day of March 1920, filed in this Court her petition praying that she be appointed administratrix upon the estate of William J. Ferguson deceased.

That the said Addie M. Ferguson having also on the 1st day of March 1920 filed in this Court her affidavit setting forth to the best of her knowledge and belief, the names and places of residence of the heirs of the said deceased, and that the said deceased died without a will:

Now on this 1st day of March 1920 the said petition comes on regularly for hearing, and proof having been made to the satisfaction of the Court that, and it further appearing to the satisfaction of this Court that the said petition sets forth all the facts essential to give the Court jurisdiction over the estate of the said deceased, and proof under oath in open Court having been offered and taken and the evidence being closed and the said matter having been duly, regularly and finally submitted to the Court for consideration and decision, and all and singular the law and the premises being now by the Court here fully understood and considered, the Court finds the facts applicable to this matter to be as follows, to-wit:
