Lena Hapgood et vir to Dewey J. Hapgood et ux

THIS INDENTURE, Made this 25th day of March 1924 by and between Lena Hapgood and Frank H. Hapgood, her husband, parties of the first part and Dewey J. Hapgood and Ada Hapgood, his wife, parties of the second part.

WITNESSETH, That the said parties of the first part for and in consideration of the sum of One dollar to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell and Convey unto the said Dewey J. Hapgood and Ada Hapgood, his wife, the following described real property situated in the County of Skamania, State of Washington to-wit:

Beginning at the point of intersection of the old State Highway No. 8 according to the survey thereof and as established prior to 1921 with the West line of Section 1 Township 2 North of Range 7 East of W.M., the said point of beginning being 426 feet North of the North line of the Baughman D. L. C., thence from said point of beginning North 200 feet to intersection with the South line of the Red Bluff Road (said point being 931 feet South of the Northwest corner of said Section 1), thence South 70° East along the Red Bluff Road to intersection with the North line of the present North Bank Highway; thence South 60° West along the North line of said North Bank Highway 250 feet, thence in a Westerly direction to the point of beginning.

TO HAVE AND TO HOLD the same unto the said parties of the second part forever. And the said parties of the first part do hereby covenant to and with the said parties of the second part that they are lawfully seized in fee simple of said premises and have good right to sell and convey the same; that the same are free from all incumbrances and they will Warrant and forever Defend the said premises against the lawfully claims of all persons whomsoever.
