This deed is given to supersede and correct those certain deeds on file and recorded in Skamania County on the 30th day of December 1926. Page 147 of Deeds Volume V and the 8th day of March 1924, Page 512 of deeds Volume T. Said strip of land as shown on map of definite location approved May 18th, 1925 revised June 22, 1927 now of record and on file in the Directors of Highway Office at Olympia.
