Beginning at a point 890.5 feet south of the center of section 36 tp 3 N R 7 E W.M. thence south 580 feet, thence South 84°22' West 1.5 feet, thence north 57° 59' West 202.1 feet; thence North 58° 24' West 118.1 feet; thence north 11°19' West to a point 990 feet south of the north line of the Southwest quarter of section 36 aforesaid; thence north 99.5 feet; thence east to the place of beginning, containing 4 acres more or less; excepting therefrom all roads or rights of way for roads, either public or private, on, over or across the above described land, heretofore granted.
