acquired under the Master's sale aforesaid were duly sold, assigned and transferred for a valuable consideration to the grantee herein, Fir Timber Investing Company, which is still the owner and holder of the rights acquired by it by virtue of the said assignment; and

WHEREAS, there has been no redemption from the said sale, and the time allowed for such redemption has now expired; and

WHEREAS, it was provided in and by the decree aforesaid, of date March 4, 1915, that the Receiver of the Oregon-Washington Timber Company should join with the said Master in Chancery in the execution of the deed to which the purchaser at said sale should be entitled; and

WHEREAS, H. E. Collins, Receiver aforesaid has died, and George B. Guthrie has been duly appointed his successor, and is now Receiver of Oregon-Washington Timber Company, empowered under the said decree to execute the said deed on its behalf;

NOW THEREFORE, in consideration of the premises, and of the said sum of \$200,000.00, the receipt whereof is hereby acknowledged, the grantors do bargain, sell, grant, convey and confirm to the grantee, and to its successors and assigns forever, all of the following described property, to-wit:

The East Half of the Northeast Quarter of Section 25; the North Half of the North Half of Section 24; the East Half of the Northeast Quarter, and the North Half of the Southeast Quarter of Section 23; the East Half and the East Half of the West Half and the Southwest Quarter of the Northwest Quarter, and the Northwest Quarter of the Northwest Quarter, and the Northwest Quarter of the Southwest Quarter of Section 14; the whole of Section 13; the East Half of Section 11; the Southeast Quarter and the Southwest Quarter of the Northeast Quarter and the Northeast Quarter of the Northwest Quarter, and the West Half of the Northwest Quarter, and the Northwest Quarter of the Southwest Quarter, and the South Half of the Southwest Quarter of Section 12; the Southeast Quarter of Section 2; the whole of section 1; all in Township 2 North, Range 5 East, Willamette Meridian.
