E Ethelda M. Ahola devisee to State of Washington

IN THE MATTER OF State Road No. 8 Stevenson to Wind River.  
KNOW ALL MEN BY THESE PRESENTS, That Ethelda M. Ahola a widow and Ethelda M. Ahola as devisee of Peter Ahola, deceased of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Two hundred and fifty Dollars, in hand paid, receipt whereof is hereby acknowledged, has granted, bargained sold and conveyed and by these presents does grant, bargain, sell and convey unto the State of Washington the following described parcel of land situated in Skamania County, Washington, to-wit: A strip of land 100 feet wide, being 50 feet on each side of the center line of said road as surveyed over and across lots 2, 3 and 4 Section 31 Twp. 3 North range 8 east W.M. except from survey station 141+00 to station 144+00 it shall be 70 feet wide, from station 146+00 to station 148+00 it shall be 80 feet wide and from station 150+00 to the East line of said lot 4 it shall be 75 feet wide and from station 124+00 to station 125+00 it shall be 60 feet wide all on the northerly side of said center line from station 146+00 to 150+00 it shall 100 feet wide and from station 123+00 to station 125+50 it shall be 100 f feet wide all on the southerly side of said center line. This deed is given to supersede and correct that certain deed recorded in the auditors office of Skamania County and filed January 29, 1926, in Volume U of deeds Page 525. The State of Washington reserves the right to use the present road till such time as the new road is constructed and in use by traffic. As shown on that certain map of definite location approved May 18th, 1925, revised March 26 1929 of record and on file in the Director of Highways office at Olympia.
