THIS DEED made the second day of May in the year of our Lord one thousand nine hundred and
twenty-nine by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation of the State of Wiscon-
sin, grantor, to FRED BLACKBURN ROGERS of Fort Douglas in the County of Salt Lake and State
of Utah grantee, Witnesseth:

WHEREAS, by a contract in writing entered into on the fourteenth day of July, A. D., 1925
the grantor contracted to sell and convey to for the consideration hereinafter expressed, the
premises hereinafter described, which contract has been duly performed and the grantee has
become entitled to a conveyance of the premises.
