IN CONSIDERATION OF one hundred forty and 28/100 (\$140.28) Dollars, the receipt of
which is hereby acknowledged, the State of Washington does hereby grant, bargain sell and
convey unto Rena G. Swigert, her heirs and assigns, the following described tide or shore
lands of the second class, as defined by Chapter 255 of the Session Laws of 1927, situate in
Skamania County, Washington, to-wit:

All shore lands of the second class, owned by the State of Washington situate in front of,
adjacent to or abutting upon that part of lot 4 Section 11, township 1 north, range 5 east,
W.M., included in a tract described by metes and bounds as follows:

Beginning at the point of intersection of the south line of the right of way of Spokane,
Portland and Seattle Railway with the east line of said section 11 and running thence along
said right of way line S 68°24'W 490 feet; paralleling the center line of said railway and
100 feet distant therefrom; thence S 43°W 200 feet and S 15°30'E 150 feet to the meander line
of Columbia River; thence easterly, along said meander line, to the east line of said section
11; thence north along said section line to the place of beginning, with a frontage of 11.69
lineal chains, more or less, measured along the government meander line.
