

DEED RECORD W
SKAMANIA COUNTY, WASHINGTON

A strip of land 100 feet wide, (except as may be hereinafter specified) being 50 feet on the Northerly side and 50 feet on the southerly side of the center line of said road as surveyed over and across the S. E. $\frac{1}{4}$ of the S.E. $\frac{1}{4}$ Section 30, Lot 1 section 32 and the S.W $\frac{1}{4}$ of the S.W. $\frac{1}{4}$ section 29 twp. 3 North Range 8 East W.M. Except from survey station 196+50 to station 197+50 and from station 210+00 to the East line of said S.W. $\frac{1}{4}$ of the S.W. $\frac{1}{4}$ it shall be 60 feet wide on the northerly side of said center lines from station 186+50 to station 188+00 it shall be 110 feet wide from station 193+50 to station 195+50 it shall be 100 feet wide and from station 195+50 to station 197+50 it shall be 60 feet wide all on the southerly side of said center line. This deed is given to supersede and correct those certain deeds on record in the Auditors office of Skamania County and filed December 5th, 1925 in volume U of deeds page 479 and January 6th, 1926 in Volume U of deeds page 505. The State of Washington reserves the right to use and maintain the existing road till such time as the new road is constructed and opened to traffic. the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval May 18th, 1925 Revised March 26th, 1929.
