KNOW ALL MEN BY THESE PRESENTS, That George E. Cote and Edwina M. Cote, husband and wire,
or Portland State of Oregon in consideration of Ten and 00/100 Dollars, to them paid by
D. B. Ambler and Adelle M. Ambler, husband and wife, of Portland State of Oregon, have bar-
gained and sold and by these presents do grant, bargain, sell and convey unto said D. B.
Ambler and Adelle M. Ambler, husband and wife, heirs and assigns, all the following bounded
and described real property, situated in the County of Skamania and State of Washington.

All of Lot Twelve (12) and the Northerly twenty-five (25') feet of Lot Eleven (11)
being the one-quarter ($\frac{1}{4}$) of Lot Eleven (11) lying Southerly of and adjoining said Lot
Twelve (12), Washougal Riverside Tracts in Skamania County, Washington, according to the
duly recorded plat thereof on file in the office of th County Recorder for Skamania, County
State of Washington, the Southerly line of Northarly Twenty-five (25') feet of lot eleven
(11) to be parallel to the North line of lot eleven (11). together with all and singular
the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining
and also all estate, right, title and interest in and to the same, including dower and
claim of dower.
