The grantors, James G. Harris and Lucie D. Harris, his wife, for and in consideration of One dollar and other valuable consideration in hand paid, convey and warrant to E. C. Hamilton and Maggie E. Hamilton, his wife, the following described real estate, situated in the County of Skamania, State of Washington:

Commencing at a point 24 rods West of the east boundary of the James G. Harris homestead on the south line of Lot 12 and the south line of Sec. 24, Tp. 3 N. R. 7 1/2 E. Willamette Meridian, which point is also the S.W. corner of the Pusey tract; thence North 80 rods to north line said James G. Harris homestead; thence west 26 rods, thence south 80 rods, thence east 26 rods to place of beginning, containing 13 acres together with right of way for a road connecting above described tract with Ivetot Road.

Commencing at the terminus of the North line of the Ivetot Road as now constructed, thence Northeasterly to the Northeast corner of Lot 2 of Section 25 Tp. 3 N. R. 7 1/2 E. W.
