THIS INDENTURE, Made this 31st day of July, A. D. 1929, between A. C. Sly as Treasurer of Skamania County, State of Washington, party of the first part, and the County of Skamania, State of Washington, party of the second part:

WITNESSETH, That, whereas, pursuant to a real estate tax judgment entered in the Superior Court of the County of Skamania, State of Washington, on the 21st day of June, A. D. 1929, in proceedings to foreclose tax liens upon real estate, wherein the said county of Skamania, State of Washington, was given a several judgment against each of the pieces, parcels or tracts of land hereinafter mentioned for the amount set opposite thereto in the column headed "Amount of Judgment," and an order of sale duly issued by said Superior Court, a public sale of real estate was held on the 20th day of July, A. D. 1929, at the front door of the Court House at Stevenson, Wash. in said County, due and legal notice thereof first having been given according to law, at which there were no bidders offering to pay the amount of any of the hereinafter mentioned several judgments;
