THIS INDENTURE, Made and entered into this 16th day of October 1928 by and
between N.O.Anderson and Christina Anderson, husband and wife, parties of the first part
and Bacon Lake Corporation, a corporation of the State of Washington, party of the second
part, WITNESSETH:

That the said parties of the first part, for and in consideration of the sum
of one dollar to them in hand paid by the party of the second part, the receipt where-
of is hereby acknowledged, do hereby grant, ^{bargain} sell and convey unto the said party of the
second part the following described real property in Skamania County, State of Washington
to-wit:

Commencing at the N.E. corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Sec. 26 T.P. 2. N. R. 6 E. W. M.
thence west along the center line of said section 26, 500 feet, thence south 45° East of the
the East line of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ aforesaid thence north 500 feet to point of beginning
excepting and reserving unto the grantors, their heirs and assigns, their right and ease-
ment to lay on, over and across the above described land, a pipe not to exceed 6 inches
in diameter, together with the right of ingress for the purpose of repairing and maintain-
ing said pipe line.

To have and to hold unto the said party of the second part, its successors and
assigns forever.

And the said parties of the first part do hereby covenant to and with the said
party of the second part that they are the owners in fee simple of said premises; that
they have good right to sell and convey the same; that the same are free from all in-
cumberances, and that they will and their heirs, administrators and executors shall forever
warrant and defend the title thereto against all lawful claims whatsoever.
