THIS INDENTURE, Made this 12th day of September 1929 between A. C. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and Leon P. Montchalin, of Stevenson, Wash., party of the second part:

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 23rd day of June A. D. 1928, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,

WHEREAS, in pursuance of said order of the said Board of County Commissioners, and of the Laws of the State of Washington, and for and in consideration of the sum of Eighty Dollars, lawful money of the United States of America, to me in hand paid, the receipt whereof is hereby acknowledged, I have this day sold to Leon P.
