COUNTY TREASURER'S DEED.

THIS INDENTURE, Made this 31st day of August, 1929, between A. C. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and WEYERHAEUSER TIMBER COMPANY, party of the second part;

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 31st day of August A. D. 1929, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,
